*Karl Boss of 2701 Old Farm Drive, Seagoville, Texas stated he feels the concrete batch plant is in danger of tipping over and taking out power lines. He stated he thinks it would be better if it is moved to the south.*

*Mark Leonard of 6331 Southwest Boulevard, Benbrook, Texas stated the plant was moved away from the power lines. He also stated they realized the power lines would be a problem so they found a better location.*

*Mayor Childress closed the public hearing at 7:18 p.m.*

*City Manager Stallings stated he asked Junior Planner Bonner to present this item.*

*Junior Planner Bonner presented road humps and provided an example of a speed cushion by Tree Top Products. She stated the examples can vary in size and are designed to handle emergency vehicles. She stated the Resolution is for a Traffic Control Program. She stated this is a basic program which the neighborhoods have to petition and approach the City. The City is required to perform an engineering and traffic study. She stated all of the information from the engineering and traffic study is presented to the City Manager. The City Manager then provides that information to Council for a decision. She explained the cost share of the residents and the City.*

*In response to a question by Mayor Pro Tem Epps, Junior Planner Bonner stated the City only pays for the studies and the labor for the installation of the devices.*

*Mayor Pro Tem Epps asked if there was a timeframe concerning the traffic study. Junior Planner Bonner stated it is approximately three (3) to six (6) weeks.*

*At the request of City Manager Stallings, Junior Planner Bonner explained the cost share policy. She stated the neighbors share an actual percentage of the expense. It is based on an eighty-fifth (85) percentile of speed in a certain zone. She explained as the speed increases the neighbors pay less.*

*City Manager Stallings stated speed bumps will cause damage to vehicles which will cause claims, so Staff recommends this option, He stated citizens have to pay within a certain time period before installation.*

*Motion to approve Agenda Item #8 – Hernandez, seconded by Magill. Councilmember Hernandez stated he wanted to amend his motion. Councilmember Magill rescinded his second. Councilmember Hernandez rescinded his motion.*

Section 19.02.007(a) of the Code of Ordinances provides for the permitted time and day to place garbage receptacles at the curblineline for collection and for the time the same must be removed from the curblineline after collection. This section does not provide any requirements for the placement and storage of the garbage receptacle once it is removed from the curblineline and on non-collection days.

**THE CITY OF SEAGOVILLE, TEXAS**

**ORDINANCE NO. \_\_\_-18**

**AN ORDINANCE OF THE CITY OF SEAGOVILLE, TEXAS, AMENDING THE CODE OF ORDINANCES BY AMENDING ARTICLE 19.02, SOLID WASTE, BY AMENDING SECTION 19.02.007, PLACEMENT FOR COLLECTION, SUBSECTION (a), TO PROVIDE FOR THE PLACEMENT AND STORAGE OF RECEPTACLES ON NON-COLLECTION DAYS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Section 19.02.007(a) sets forth the permitted time and day to place garbage receptacles at the curblin for collection, as well as the time the same shall be removed from the curblin after collection; and,

**WHEREAS**, the City does not currently regulate the placement and storage of the garbage receptacle on non-collection days; and

**WHEREAS**, Council desires to establish permitted locations for the placement and storage of garbage receptacles on non-collection days to prevent the same from being placed and/or stored in areas that create a public nuisance; and

**WHEREAS**, after discussion and consideration, the City Council determined that Section 19.02.007(a) should be amended to provide for the location, day and times of placement and storage of garbage receptacles on non-collection days.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SEAGOVILLE, TEXAS:**

**SECTION 1.** That the Code of Ordinances of the City of Seagoville, Texas be, and the same is, hereby amended by amending Article 19.02, SOLID WASTE, by amending Section 19.02.007, Placement for collection, subsection (a), which shall read as follows:

**"ARTICLE 19.02 SOLID WASTE**

**Division 1. Generally**

**Sec. 19.02.007 Placement for collection**

(a) Every owner, occupant, tenant or lessee of a dwelling or public building used for residential, business or commercial purposes shall be required to maintain or cause to be maintained constant supervision and surveillance over the garbage receptacles and small brush on his premises. In areas where garbage or small brush are collected from the street, the garbage receptacles shall be placed at the curblin no earlier than 6:00 p.m. of the date preceding that on which it is to be collected and no later than 7:00 a.m. on the day of collection, and shall be removed from the curblin no later than 8:00 p.m.

on the day on which it is collected. All garbage receptacles shall be placed and/or stored  
\_\_\_\_\_ on non-collection days.

.....”

**SECTION 2.** If any section, article paragraph, sentence, clause, phrase or word in this ordinance, or application thereto any persons or circumstances is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this ordinance; and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

**SECTION 3.** That all provisions of the Ordinances of the City of Seagoville, Texas, in conflict with the provisions of this ordinance be, and the same are hereby amended, repealed, and all other provisions of the Ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

**SECTION 4.** This Ordinance shall become effective from and after its date of passage in accordance with law.

- (5) information regarding a social, ceremonial, or community event organized or sponsored by an entity other than the governing body that was attended or is scheduled to be attended by a member of the governing body or an official or employee of the political subdivision; and
- (6) announcements involving an imminent threat to the public health and safety of people in the political subdivision that has arisen after the posting of the agenda.
