2. **ZONING REQUEST Z2019-12: PUBLIC HEARING** Conduct a Public Hearing, discuss and make a recommendation to City Council on a request to amend the zoning on approximately 20+ acres of unplatted Tract 1 of Jeremiah H. Halford Abstract 570 located approximately 150-feet northwest of the intersection of Lasater Road and Wynnegate Drive from AG, Agriculture, to PD-19-01, the first plan development created in 2019, for a subdivision only partially located Seagoville. The request will define development regulations and improvements to Lasater Road.

 - II. Commission receives the Staff report and action recommendation.
 - III. Commission receives the Applicant rebuttal to Staff report. (Applicant or their representative to be recognized by the Chairman. Once recognized, they are to speak from the podium.)

ZONING REQUEST Z2019-26: PUBLIC HEARING Conduct a Public Hearing, discuss and make a recommendation to City Council on a request to amend the zoning on a total of approximately 5.6± acres from PD-LR, Plan Development with Local Retail base zoning, on Lot 1 Block 2 Seagoville Place Addition and PD-A, Plan Development with Apartment base zoning, on Lot 1 Block 1 Seagoville Place Re-plat, to PD-19-02A, second amendment to PD Ord 580 with base zoning of Commercial for the entire subject area.
