2. **ZONING REQUEST Z2019-28: PUBLIC HEARING** Conduct a Public Hearing, discuss and make a recommendation to City Council on a request to consider a text change amendment of the City of Seagoville Zoning Ordinance, Division 32. Regulations Applicable to All Districts, Section 25.02.716, "Site and Building Lighting", by clarifying certain lighting and where it can be placed in residential and non residential districts.
 - I. Chairman opens the public hearing.
 - II. Commission receives the Staff report and action recommendation.
 - III. Commission receives any public comments. (Chair to state that individuals who wish to speak must come to the podium to be recognized. Those speaking need to provide their name and address to City Staff by printing this information on the provided paper on the podium.  - IV. Chairman closes the public hearing. (Chair to state no further comments will be accepted from the public during this meeting. The public is welcome to stay and observe, but they may not comment or otherwise disrupt the meeting.)
 - V. Commissioners hold their discussion.
 - VI. Commissioners move, 2nd, and vote on their recommendation to City Council on this item.


