
2. **ZONING REQUEST Z2019-26: RECOMMENDATION** Discuss and make a recommendation to City Council on a request to change the zoning on approximately 5.6+acres, being Lot 2 Block 1 Seagoville Place Addition, commonly referred to as 2110 North Highway 175, and Lot 1 Block 1 Seagoville Place Re-plat, commonly known as 2108 North Highway 175, Seagoville, Dallas County, Texas, from PD-LR, Plan Development with Local Retail base zoning and PD-A, Plan Development with Apartment base zoning, to PD-C, Plan Development with base zoning of Commercial. This request held its public hearing on September 26, 2019, but action was tabled due to the lack of a concept plan for the new plan development.
